California State University, Dominguez Hills, invites applications for a full-time position at the rank of lecturer of operations management in the Department of Information Systems and Operations Management, College of Business Administration and Public Policy. The appointment will be effective spring semester 2009. Appointment and start date are subject to the availability of funds.

POSITION DUTIES AND RESPONSIBILITIES

Teaching duties may consist of day or evening classes. Additional responsibilities include maintaining academic or professional qualifications as required by AACSB accreditation standards and the business program's policies that define academic and professional qualifications of faculty. The position requires service consistent with the mission of the University and the College of Business and Public Policy. The policies on academic and professional qualification state that published research in support of the mission is one means to maintain academic or professional qualification, as is high level involvements with business or other appropriate practitioner communities. Teaching responsibilities will include primarily undergraduate courses and possibly graduate courses, and may include online courses.

QUALIFICATIONS

- A. **Required:** A masters degree in business administration (with an appropriate concentration), operations management, operations research, industrial engineering, industrial management, logistics, or supply chain management. Degrees from closely related fields and majors also meet the requirement. Academic scholarship or significant managerial or professional practitioner experience that meets the business program's standards for academic or professional qualification. A record of or potential for effective teaching and the ability to maintain academic or professional qualification in the field of instruction. Experienced practitioners with an interest in higher education are encouraged to apply.
- B. **Preferred:** PhD or appropriate terminal degree or high level and extensive managerial or professional practitioner experience. The ability to interact effectively with professionals in the discipline. Experience in or potential for teaching on-line courses. Ability to build programs and attract students at the undergraduate and graduate levels.

RANK AND SALARY

Appointment will be at the rank of full-time lecturer. Compensation, benefits, workload, and related factors are competitive.

APPLICATION PROCEDURE

To ensure full consideration, applications should be submitted no later than October 1, 2008. Thereafter, review of applications will begin and will continue until the position is filled. Anticipated start date for this full-time position is the start of the spring semester 2009, which begins in late January. Candidates are requested to submit a cover letter and résumé to Dr. Raoul J. THE DEPARTMENT

The Department of Information Systems and Operations Management has 10 full-time faculty. THE CAMPUS
